Private Track Hire Agreement Terms and Conditions

The Ipswich City Dirt Kart Club track and amenities are available for hire by financial club members. Conditions and charges are as follows:-

Charges:-

The track and amenities can be hired for a period up to eight (8) hours for \$300.00 for up to 10 drivers. Any additional drivers incur a charge of \$30.00 each.

If the hirer requires the use of the grounds lights, an extra charge will be incurred. Charges are at the discretion of the ICDKC and IWMAC.

Please Note – Access to the canteen is not included in the hire fee.

Conditions:-

1. Track hire approval is at the discretion of the Executive Committee.
2. Current ICDKC “Rules of Racing” apply and must be followed. If at any time throughout the hire period, it is deemed that the Rules of Racing have been breached, the track hire agreement will be cancelled immediately and all karts and drivers are to leave the premises. Further penalties may apply as per Appendix ‘A’.
3. Charges remain the same whether the track is hired for a single hour or entire eight hours. Late starters are not entitled to continue after the track hire period has expired.
4. No more than 8 karts are to be on the track at any time.
5. Track hire will only be approved to financial club members. One person (participating on the day) must be nominated as the contact person. This person is responsible for the collection and payment of monies, distribution and collection of the Disclaimer Driver forms, and will be the person contactable in the case of any disputes or emergencies.
6. All hire fees are to be paid in advance. Any additional monies raised on the day are to be paid on the next business day.
7. Grounds are to be left in a clean and tidy state. All rubbish is to be placed into the large industrial bins. No rubbish is to be left in the toilet bins.
8. The water truck and dam pump are only to be operated and used by an accredited club member. The track is to be dragged and prepped prior to use on the day of hire by the nominated water truck driver for the day. Prestarts are to be followed and completed for the water truck and dam pump prior to use. Time taken to carry out track prep and pre-starts is included in the hire period time.
9. The use of the track for private hire can be deemed as training which falls outside of our current rules. Although we do not encourage junior and senior drivers to be on the track at the same time (as per Rule 7.13), we acknowledge the ability to do so and insist common sense is applied in these instances.
10. Any damage to ICDKC property is to be paid for by the Hirer.
